### COURSE DESCRIPTION

As a historical figure, Jesus of Nazareth is elusive because the earliest testimony about him is sparse or one-sided, and because he is a figure of differing importances for three great religious communities in today's world--Judaism, Christianity and Islam. It is therefore difficult and challenging to study his origins, career and teachings.

#### FORMAT

The weekly meeting times (Tuesdays, 3:30 to 5:30 p.m.) will be used primarily to present reports on assigned topics. Each report will take up approximately one hour. Students should plan to use one-half of the hour to present the report, so that the other half-hour can be spent in discussion of the topic at hand. A schedule of reports should be available by the second week of the term.

While participants are preparing their reports, they will select a term paper topic--preferably one which concerns the subject of the colloquium--by the third week of the term. They will hand in a first draft of the term paper by Friday of the ninth week of the term, and a second draft (revised in accordance with the instructor's comments and the student's own second thoughts) by the day and hour assigned in the timetable for the final examination. The suggested maximum length of the second draft: between ten and twenty pages.

First draft of paper 30%, second draft 35%, discussion section reports 35% of final grade.

Next, keep your list handy, and check each name in the ENCYCLOPAEDIA JUDAICA, keeping also at hand (for ready reference on the history of the ancient Hebrews) W. L. Langer, ENCYCLOPEDIA OF WORLD HISTORY (5th ed.), pp. 42-46, 93-95. What else do we know about the ancestry Matthew and Luke ascribe to Jesus? What is the significance of these two lineages?
