### Seminar in Modern French History

This course will focus on key issues in the political, social and cultural history of France in the nineteenth and twentieth centuries. Particular attention will be given to contemporary historiographical debates (on both sides of the Atlantic) on such topics as working class history in the nineteenth century or the Vichy régime.

Requirements: Two short (5-7 pages) review essays and one long paper (15-17 pages) on a topic to be agreed upon with the instructor. Students will also be responsible for leading at least one discussion.
