Readings in American Intellectual History

In this seminar we will be reading and discussing a wide range of recent books and articles in American intellectual and cultural history. Weeks 2-13 are organized on a chronological basis, while Week 14 focuses on issues of theory and methodology. The dual aim of the seminar is to survey recent work on topics of interest to historians of ideas, and simultaneously to explore the various methodologies and approaches intellectual and cultural historians use.

Reading and Assigned Papers.

At the first organizational meeting, each student will choose a book or article to read for each week. (Each student's choices should result in about a half-and-half mix of books and articles.) Each student will then write a 2-3 page essay on each week's readings and make sufficient copies (in Xerox or ditto form) for distribution to the full class, plus two copies for the instructor. (One copy will be returned to you with comments, the other is for my files.) These papers should be in the form of a 500-600 word review, such as one might write for a journal like the American Historical Review, concisely summarizing the main themes or thesis of the work; discussing the organization, style, or use of sources; and critically assessing strengths and weaknesses.

Long Paper. One of these reviews should be expanded into a longer paper of 8-12 pages in which the analytical and critical discussion in enlarged and deepened. (The reviews in Reviews in American History might serve as a model for this form.) This longer paper may be submitted at any time during the semester; it must be completed, together with all the other papers, by the final class meeting.

Class Discussion

At each class meeting, two or three 15-minute oral reports will be presented, following a schedule to be worked out at the first meeting. Each student will give two oral reports in the course of the semester. These reports should summarize and critically evaluate the work, and suggest what it contributes (or fails to contribute!) to our historical understanding. After each report, another student, designated the "Respondent", will comment for about 10 minutes on the presentation and raise questions about any matters left unclear in the report. We will then have about 15-20 minutes of general discussion. The books or articles to be the subject of these oral reports have been starred (*) on the attached lists of weekly readings.

Grading

Grading will be based on the short papers, the longer paper, and discussion participation including the oral reports.
