## **RESEARCH IN PROGRESS:**

Two potential book projects have inspired research and reflection. The first, tentatively entitled *Latin America at the Movies: Between Human Rights and Social Justice*, is an interpretive history of Latin America and the world during the last half-century, through dialogue with film as a cultural archive. It tells how Latin Americans created a double-imperative – human rights *and* social justice, as entangled values in tension, the one irreducible to the other – and how grass roots organizing for better livelihoods and values figured into the story, in ways both inspired and troubling. The book also shows how Latin America's history of human rights and social justice shatters standard world history narratives of human rights.

The second project is a more personal history – a memoir, tentatively entitled *Night Soul: Living History with Survivors from Auschwitz to Chile Stadium*, on how I came to learn ways of doing history and why it matters from survivors of catastrophe.

Historical memory evaluation project leader, 2016-2017, Centro Nacional de Memoria Histórica (CNMH), Bogotá, Colombia:

The charge was to research and write a comprehensive analytical description and critical evaluation of the methodological and pedagogical work of the CNMH and its predecessor group, the Grupo de Memoria Histórica (GMH), during 2007-2017. The evaluation report served as material for the process of reflection and preparation for a possible peace transition in Colombia after a half-century of war. Jacob (Jake) Blanc, Debbie Sharnak, Stern, and Bridgette Werner served as the research and analysis team, and as collaborating authors. The 158-page report was submitted in final form to the CNMH in November 2017. A revised version, framed within a broad historical interpretation of violence and the memory question in contemporary Colombia was published by CNMH as a book in 2018 and is listed above in the publications section.

Expert witness work, 2014-2016, in the human rights case for the torture and extra-judicial execution of Víctor Jara, brought to jury trial in U.S. Federal District Court, Middle District of Florida, Orlando Division, Case No 6:13-cv-01426-RBD-GJK: Joan Jara, Amanda Jara Turner and Manuela Bunster, Plaintiff, versus Pedro Pablo Barrientos Núñez, Defendant. The Honorable Judge Roy Dalton, Jr., presided.

The case was brought to trial under the U.S. Torture Victim Protection Act. The Center for Justice and Accountability in San Francisco, in collaboration with attorneys in New York and Florida, organized the legal team for the plaintiffs. The 46-page expert witness report, supplemented by 16 exhibits and 4 appendices, was submitted to the court on 14 October 2015. The jury

trial opened in Orlando, Florida on 13 June 2016. Expert witness testimony and cross-examination took place on 20 June 2016. The Jara family survivors – Víctor Jara's widow Joan, and his daughters Amanda and Manuela – won the case. The jury found Barrientos, a former officer of the Chilean army, liable for both torture and extra-judicial execution, and awarded damages of \$28 million (\$8 million compensatory, \$20 million punitive). The jury returned its verdict on 27 June 2016.
