### **Projects of Historical Reckoning and Public-Facing Work**

[UW-Madison Public History Project](#): “Sifting and Reckoning: UW-Madison’s History of Exclusion and Resistance”

The PHP explores the history of exclusion and resistance on our campus from its founding to the present. Chancellor Rebecca Blank named me co-chair of the committee that established the project in 2018. I served as chair of the Project steering committee, 2019-2023, working closely with the project director, Kacie Lucchini Butcher, and was a co-author of the text of the Fall 2022 museum exhibit unveiling this research.

[Report to the Chancellor on the Ku Klux Klan at UW-Madison](#)

In August 2017 Chancellor Blank named me co-chair of a study group on the Ku Klux Klan at UW-Madison, whose mission was to assess the significance of two 1920s campus groups bearing that name. A year of research and deliberations with a large committee produced a 2018 report to the chancellor, linked [here](#), including numerous recommendations to acknowledge and address the history of exclusion on the campus.

[Our Shared Future](#): UW-Madison's educational framework for engaging the campus's Indigenous past and present

This project of the Provost's office sponsors an annual event, "Treaty Day," recognizing that the campus stands on ancestral Ho-Chunk lands; it also offers modest funding to campus units to support educational activities focused on Indigenous history and culture. I have participated in this work since its inception in 2019.

Teejop Community History Project: a Ho-Chunk-led project, supported by the Madison Community Foundation

This project, devised and led by Ho-Chunk community members, worked to articulate themes representing the significance of the Four Lakes region (today's Greater Madison; in the Ho-Chunk language, "Teejop") for Ho-Chunk history and culture. Ongoing work includes a heritage trail and public art projects. I was invited to join this group in 2018.

["Black History for a New Day"](#): A community-based course educating adult non-Black allies in Black history

In 2015 I collaborated with Rev. Dr. Alexander Gee (Senior Pastor, Fountain of Life Congregation/Nehemiah Center for Urban Leadership Development) to create this course, which runs at least once a year over 7-9 evening sessions at Rev. Gee's church. I was lead history instructor for its first year. I subsequently recruited additional university colleagues onto the teaching team. The course continues to run, now online, and typically enrolls over 200 participants.

Goal: To create a shared resource for scholars of Ho-Chunk history and culture, providing links to and descriptions of scholarly works, published primary materials, and archival and museum collections on [Mukurtu](#), a free, mobile, open-source platform built in collaboration with Indigenous communities to manage and share digital cultural heritage. Constructed in collaboration with Molli Pauliot (Ho-Chunk), with the assistance of students in the Tribal Libraries, Archives, and Museums practicum at UW-Madison.

This project subsumes and incorporates an earlier effort, the Ho-Chunk Petitions Project.
